LCCF Turned 30!

The Lawrence County Community Foundation recently hosted a wonderful evening celebrating thirty years of making a positive impact in Lawrence County. The event was held at the beautifully restored Indiana Limestone Building. Guests attending the dinner enjoyed a delicious meal, bid on local goods, arts, and activities at the silent auction, and were entertained by magician Dwayne Hill.

Brent Maudlin, LCCF Board President, explained how gifts to the Community Foundation benefit the community forever. Gifts are permanently invested; while the principal grows, the earnings are granted into the community year after year. He encouraged everyone to consider including the Community Foundation in their will.

Brent also announced LCCF would be awarding \$30,000 in Surprise Anniversary Grants. Ten \$3,000 grants were awarded over several weeks. The first grant recipient, White River Humane Society, was announced at the dinner.

Jim Buher spoke about LCCF's expertise and experience in responsibly processing complex gifts.

LCCF is poised to continue their strong, beneficial presence in Lawrence County for the next thirty years and beyond.

Over \$100,000 in Grants Awarded

LCCF awarded over \$70,000 in Impact Grants to eighteen local agencies in the 2023 Open Grant Cycle. An additional \$8,200 was awarded in Boost Grants to five organizations.

LCCF also issued Challenge Grants totaling \$24,572 to three organizations: City of Mitchell, Lawrence County Horse & Pony Club, and Junior Stars. All three organizations met their match and received their grant.

Brent Maudlin, LCCF Grants Committee Chair, said, "This year, more so than past years, we had a long list of applicants with projects covering one end of the county to the other. The committee was very thoughtful and carefully considered every application. The grant requests surpassed the dollars available, and the committee had to make tough decisions. We know the projects awarded will impact many segments of the community and we're thankful for all the volunteers that will use these grant dollars along with their hard work to grow our community one project at a time."

Pennington Grants for Disadvantaged Elderly

LCCF Awarded \$26,291 in grants to seven non-profit organizations from the Margie Marie Pennington Fund for the Elderly. The awards ranged from \$1,625 to \$7,500. The intent of this year's grants included supplying nutritional supplements for senior cancer patients, providing assistance required to remain in one's home, to assistance with cat adoption.

Margie Pennington bequeathed funds to LCCF for an endowment to assist organizations with programs helping Lawrence County elderly that



are disadvantaged or homeless. Our community is fortunate that there are grant dollars specifically focused on projects benefiting the elderly. This endowment funds worthy projects that may not have been possible otherwise.

Lawrence County Horse and Pony Club

The Lawrence County Horse and Pony Club has been growing—they are 60 active members strong. With the growth of the program, it became clear they needed to make some improvements to accommodate all the participants. First on the list was to improve and expand the second horse arena. Of course, a project like this requires funds. In an effort to raise the needed funds, Amber Thorne, Club President, applied for an LCCF grant and was awarded a challenge grant. If the Club raised \$3,500, LCCF would award a grant for \$6,500. The kids were gung ho and quickly got to work raising funds. The challenge was met and the grant awarded.

The grant will provide more room for the riders as the main arena only accommodates 15-18 riders. Once the second arena is completed it will accommodate another 15 riders comfortably. This will help with their summer camp which had 35 campers last summer, double the number who can attend their summer clinic, and speed up horse shows during the fair.

Board Member Spotlight




Getting to Know: Bill

Cement City Industries

Springville Community Association

A dedicated group of Springville residents have been working tirelessly to restore the Springville Gym. Past grants have been put toward stabilizing and capping the gym walls allowing for a new roof. A 2023, \$3,900 Impact



grant will purchase doors and a \$5,744 Springville Community Heritage Grant will help purchase fixtures for the restroom.



Heritage funds were established for smaller communities in Lawrence County to help local community groups enhance community projects.

Avoca Park

One component of Lilly Endowment Inc. GIFT VII was a Leadership Project. The first phase of the Leadership Project was to research the strengths and needs of our community. With the assistance of E-Solve Consulting, LCCF held community meetings and surveyed the community to get input on what community members liked about our community and where they thought it could be improved. From the information collected, recreational opportunities emerged as a need in our community.

Marshall Township in particular had a strong need for a community park. LCCF partnered with the Trustee and the Avoca Park Board to enhance the park at the former Avoca Fish Hatchery. For nearly 100 years a 40-acre tact of land in Marshall



Township served as a DNR fish hatchery. In 2013, DNR decided to phase out and decommission the hatchery and deed the land to Marshall Township. The Township assessed the state of the park, considered its potential, and developed a plan. LCCF worked with the park to prioritize their plans and awarded a \$124,500 grant to expand the playground and provide handicap accessible restrooms.



What a difference these enhancements have made. The park is quickly becoming a vital part of the community.

Endowment Distributions

Many permanent, designated endowments have been created by generous donors that want to provide support to specific local institutions now and in the future. These endowments, through annual payouts, provide permanent funding and can have a significant impact on a nonprofit institution for years to come.

2022 designated endowment and other targeted distributions totaled \$79,814.

Grant Cycles

Local nonprofit organizations, schools, and governmental agencies are invited to apply for grants through the online grant portal. The Impact and Boost Grant cycle exists for any qualified agency serving our county, the Pennington Grant cycle focuses on elderly, disadvantaged citizens, and a grant cycle is available for area classroom teachers.

Grant cycle distributions totaled \$138,249 in 2022.

COVID Relief

In response to the pandemic, the Community Foundation and its partners came to the aid of area schools and non-profits struggling with new, unprecedented challenges. Support included grants for virtual learning, equipment, cleaning supplies, basic needs such as food and shelter, and PPE.

COVID-related support since 2020 has totaled \$266,001.

Scholarships

Lawrence County Community Foundation is honored to administer the Lilly Endowment Community Scholarship, which has awarded \$3,241,544 through 2022. Many donors have created scholarships as well, with the intent of providing assistance to local students wishing to pursue higher education.

In 2022, scholarship funds awarded \$88,904.

Giving Indiana Funds for Tomorrow (GIFT)

Lawrence County Community Foundation has been partnering with Lilly Endowment since 1993 to build our communities through the GIFT initiative. Through direct community grants, challenge grants, and capacity-building grants, Lawrence County Community Foundation has secured GIFT grants totaling \$4,074,927.

Collaboration

When funding opportunities arise, the Community Foundation collaborates with other funders for even greater impact in our community. Over the years, we have partnered with the following agencies: Duke Energy, General Motors Foundation, IU Health Foundation, United Way, Smithville Charitable Foundation, Regional Opportunity Initiatives (ROI), OCRA, City of Bedford, and the CAPE partners.

Through collaboration, the Lawrence County Community Foundation has brought \$5,491,910 to Lawrence County.

Lilly Endowment recently announced Gift VIII (Giving Indiana Funds for Tomorrow, Phase Eight). The GIFT initiative aims to support Indiana's community foundations as they play central roles in supporting and strengthening our communities. LCCF has applied for a \$750,000 GIFT VIII Matching Grant. Through this grant, your gift to any

unrestricted endowment held by the Lawrence County Community Foundation will be matched 2 to 1, tripling your gift and your impact on our community. Your \$50 gift becomes \$150; your \$200 gift will become \$600, your \$1,000 gift will become \$3,000. The match period is October 1, 2023, through December 31, 2025, while grant funds remain.

Gifts to unrestricted endowments are particularly beneficial to the community. Unrestricted endowments fund our general community granting. They are flexible funds that can be used for a wide variety of community needs: education, arts, workforce development, safety, food insecurity, senior citizens, recreation, homelessness, recovery, small communities, youth, animals, and more. Furthermore, this flexibility will provide funds to meet tomorrow's unknown needs as they emerge.
