The Martin County Community Foundation was established by citizens of Martin County in 1999. Martin County Community Foundation is a proud partner in the Community Foundation Partnership, Inc., the legal entity under which the Lawrence and Martin County Community Foundations operate. A local board retains the responsibility for the vision of the Martin County Community Foundation and focuses on asset development and grantmaking in Martin County. Funds donated for Martin County stay in Martin County.

Over the years, many, many donors and area businesses have trusted the Community Foundation to help meet the ever-changing needs of our county. Through grantmaking, collaboration, and securing grants from other funders, **the total support to the citizens of Martin County through 2022: \$13,992,028.**

Endowment Distributions

Many permanent, designated endowments have been created by generous donors that want to provide support to specific local institutions now and in the future. These endowments, through annual payouts, provide permanent funding and can have a significant impact on a nonprofit institution for years to come.

2022 designated endowment and other targeted distributions totaled \$194,939.

Grant Cycles

Local nonprofit organizations, schools, and governmental agencies are invited to apply for grants through the online grant portal. The quarterly Impact and Boost Grant cycles exist for any qualified agency serving our county and an annual grant cycle is available for area classroom teachers.

Grant cycle distributions totaled \$192,449 in 2022.

COVID Relief

In response to the pandemic, the Community Foundation and its partners came to the aid of area schools and nonprofits struggling with new, unprecedented challenges. Support included grants for virtual learning, equipment, cleaning supplies, basic needs such as food and shelter, and PPE.

COVID-related support since 2020 has totaled \$71,419.

Scholarships

The Martin County Community Foundation is honored to administer the Lilly Endowment Community Scholarship, which has awarded \$3,246,870 through 2022. Many donors have created scholarships as well, with the intent of providing assistance to local students wishing to pursue higher education.

In 2022, scholarship funds awarded \$48,907.

Giving Indiana Funds for Tomorrow (GIFT)

Martin County Community Foundation has been partnering with Lilly Endowment since 1993 to build our communities through the GIFT initiative. Through direct community grants, challenge grants, and capacity-building grants, Martin County Community Foundation has secured GIFT grants totaling \$2,907,626.

Collaboration

When funding opportunities arise, the Community Foundation collaborates with other funders for even greater impact in our community. Over the years, we have partnered with the following agencies: Duke Energy, IU Health Foundation, United Way, Smithville Charitable Foundation, Regional Opportunity Initiatives (ROI), OCRA, and the CAPE partners.

Through collaboration, the Martin County Community Foundation has brought \$6,134,000 to Martin County.
